Petitioning for Guardianship of Minor **Person Only** §48.9795, Wis. Stats.

Note: These are guidelines for establishing a minor guardianship of the **person only**. For information on how to petition the court for guardianship of the estate of a minor, please see guideline for guardianship of minor of estate.

- ❖ A packet of forms is available from the Register in Probate for \$5.00.
- ❖ You may access all probate forms on the internet at: http://www.wicourts.gov/forms1/circuit.htm
- ❖ If you do not understand the forms or your duties as the petitioner, please seek advice from an Attorney.
- Complete the below forms and either mail them to us or drop them off at the Dodge County Probate Office.
- ❖ The Register in Probate will review your paperwork and will deposit your Guardian ad Litem Trust payment of \$250.00.
- ❖ The Register in Probate will appoint a Guardian ad Litem, schedule a hearing and generate an order appointing Guardian ad Litem.
- ❖ When you pick up the paperwork you will be given a copy of the paperwork to serve on all interested persons.
- ❖ The Affidavit of Service needs to be completed after you serve the documents on the interested persons and file it with the Court **before** the hearing.

<u>JD-1825</u>	Affidavit of Service to be filled out once you have served of all documents on the interested parties.

GAL Fees	Dodge County requires a GAL fee deposit. \$250.00 (each additional child is an additional
	\$50.00. You will be responsible for any additional fees charged by the GAL.
