Lifeline® or Personal Emergency Response Systems (PERS) enable you to call for help from your home with the touch of a button if getting to a telephone is not possible.

Lifeline® and Personal Emergency
Response Systems come with a button
(worn on a pendant or wristband). Pressing
the button automatically connects you to the
response center. The response center will
respond to your call, often by way of a 2way voice intercom. The response center
will ask what your urgent need is and then
will send someone to your aid.


