To bring the monument to Dodge County will take about \$100,000. The effort is currently in the discussion phase, but more information and a plan moving forward should be released in Spring.

to round up and donate, and the volunteers giving their time, baking, cooking and serving at the brat fry. Thanks to the knowledgeable people on hand for their expertise to field questions about the GSMT through the month. Most importantly, Thank You to the store manager and staff, ensuring that everything ran smoothly throughout the month and during

the brat fry by helping coordinate everything. It truly is a blessing to see how many caring individuals are involved

Everyone's arduous labors netted a grand total of \$3,961.70 for the GSMT in September. The one-day total for the Brat Fry/Bake Sale - \$358.00, and the total for the month of September RUFAC - \$3,603.70.

GSMT PHASE 2 RECEIVES \$190,000 DNR GRANT

The County was notified in September that the GSMT #2 was selected for up to \$190,000 in State Stewardship funding for the construction portion of the project. The

Federal TAP grant is already covering up to 80% funding for design and construction. . Design and Engineering work should be at 60% completion by end of the year. At the 60% milestone, acquisition efforts can begin. The majority of the trail will be located within the existing right of way of State Hwy 33, however some temporary grading easements and a few permanent ones will be required. Based on the Federal funding

schedule, construction is slated for early 2026, assuming all designs and acquisitions are completed by November 2025 (and all sufficient local funding is in place). We are close to having all the local funds needed for construction, assuming the final bid amounts are within our estimates. Donations are still needed and much appreciated.

GSMT PHASE 3 FEASIBILITY & PRELIMINARY DESIGN

Phase 3 (Wild Goose Trail to Beaver Dam) was awarded American Rescue Plan Act (ARPA) funds by the County Board to conduct feasibility and preliminary design and

analysis of the route needed for filing grant applications. MSA Professional Services has been selected for the work. A contract is being finalized that will allow commencement of work this winter. Final design, acquisition and construction will be dependent on the timelines needed for sufficient grants and donations. Total project cost estimates are \$4.5 - \$5 million. Grants could cover as much as

80% - 90%. Significant grants and donations will be needed to fund this largest segment of the Gold Star Memorial Trail. A fund for this phase was established a few years ago to receive the needed donations.

We were open the first Sunday of the month from 1:00 to 4:00 p.m. in conjunction with the Lebanon Historical Society and the Ashippun Historical Committee from April through October. These open houses afforded us the opportunity to have conversations with people interested in visiting and viewing our museum. A bonus to some of those conversations have led to us receiving additional donations to the museum. Stay current with the Friends Of Dodge County Parks, Inc. There's an old saying that states, "The older you get, the faster time goes." This sure holds true this year. It seems like just yesterday we were opening our parks for the camping season. As I write this our camping season has already ended. Where did the time go?

This season was exceptionally busy managing park improvement projects for both Astico and Harnischfeger Parks.

ASTICO PARK

We welcomed two new staff members at the park this season: Park Attendant, Kaylee Hill and volunteer Camp Host, Eric Henninger. Due to all the rain and flooding this season, a third of the



sites were closed limiting the options available for campers. Preparations continued for the new restroom/shower building and pavilion with anticipated completion of the project on or before July 15, 2025.

DERGE PARK

We welcomed new volunteer Camp Host Charles Gottschalk this season. Several



campsites were closed periodically throughout the season due to flooding. Electrical upgrades and the Fish Cleaning Station were completed.

HARNISCHFEGER PARK

We welcomed David Baumgartner and Bonnie Ayers as new volunteer Camp Hosts this season. The campsite pad reconstruction was completed. This included making Site 4 a drive-through site and eliminating Site C. The site upgrades to include 20/30/50-amp pedestals and water hook-ups at each site is scheduled to be completed prior to the end of the year.



LEDGE PARK

Ledge Park remained our top visited park again this season. The hiking trails along the Niagara Escarpment and the overlook are very popular attractions. A new firewood shelter is being constructed by the restroom/shower building, across from the Host Site in the off-season.

NITSCHKE MOUNDS PARK

Red Wolf Trail planning continues; to include quotes for the boardwalk. The installation of solar power to the pavilion for educational presentations is scheduled to be completed by the end of the year. A Wisconsin Archaeology in Public Education Grant was received for educational signage updates for the pavilion. Thank you to Ryan Howell, Effigy Mounds Initiative, Kurt Sampson, Dodge County Historical Society and Bill Ehlenbeck, Dodge County Land Resources and Parks for their efforts to obtain this grant.

GLACIAL RIVER TRAIL

The Dodge County Highway
Department assisted with spring trail
maintenance by sweeping the trail.
General maintenance efforts continued
throughout the season.

WILD GOOSE STATE TRAIL

Our park staff stayed busy this year with tree removal from the WGST and the adjacent horse trail. The flooded conditions saturated the ground and caused numerous large trees to uproot and block the trails. Several bridges were resurfaced and repaired by park staff and the Dodge County Highway Department. This will be an ongoing process as the current bridges begin to wear and age. The WGST is open for snowmobile and ATV/UTV use during the winter months (Dec 1 - March 31) when conditions allow. Please check the Trail Status Hotline at (920) 386-3705 for current trail status prior to riding on the trail.

In conclusion, thank you to all our staff and volunteers for your support, dedication and hard work that make our parks and trails what they are. Thank you to the Friends of Dodge County Parks, Inc. for your commitment and promotion of the great outdoor resources we have. A special thank you to Sergeant Marty Koutnik and the Burke Correctional Center work crews for all your help again this year.

Dodge County operates five parks and three recreational trails, providing a perfect year-round escape to the scenic rural countryside to relax or take part in many recreational activities available. The County Parks are located at various points around Dodge County, providing scenery and views.

ASTICO PARK ~ Located 3 miles east of Columbus, is a 100- acre park on the Crawfish River and features campsites, hiking trails, canoe/ kayak rentals, fishing access, picnic shelters, a naturalist program area, and more. Potential projects include trail expansions/improvements, playground upgrades, improved ADA accessibility, and invasive species vegetation control. DERGE PARK ~ Located northwest

of Beaver Dam, is a 13-acre park that provides access to the 6,600-acre Beaver Dam Lake and features campsites, a boat launch, an ADA accessible kayak pier, and fishing access. Potential projects: new fishing/docking pier, improved shoreline fishing access with benches & landscaping, and parking expansion.

HARNISCHFEGER PARK ~ Located along the Rock River is 8 miles east of Watertown. This 132-acre park contains a variety of terrain, vegetation, and facilities for multiple recreation opportunities. The park hosts the annual FallFest on the last Saturday in September. New to the park are Vintage Farming displays in the north barn & building. The park features a clubhouse and picnic shelters for group picnics and activities. There are hiking trails with boardwalks, campsites, canoe/ kayak rentals, fishing access, 9-hole mini-golf and 9-hole disc golf courses. Current and potential projects include mini-golf & disc-golf rehab and expansion, clubhouse improvements and expansion, a gazebo for general use, a future enclosed "Off Leash" dog run, an edible plants harvest naturalist

program, invasive species vegetation control, north barn restoration phase 3, homestead area repurposing phase 2, trail improvements and a vault toilet for the north end of the park.

LEDGE PARK ~ Located near the Horicon Marsh, is a 83-acre park that lies on and along the Niagara Escarpment and provides a breathtaking over-look of the Horicon Marsh. The park features campsites, hiking trails, picnic shelters, playgrounds, and an ADA accessible boardwalk to the edge of the ledge, overlooking the scenic Horicon Marsh. Potential projects include trail and accessibility improvements, invasive species vegetation control, pond boardwalk and more parking.

NITSCHKE MOUNDS PARK ~ Located 4

NITSCHKE MOUNDS PARK ~ Located 4 miles north of Juneau and adjacent to the Wild Goose Trail, is a 54-acre park featuring 39 pre-historic Native American animal, conical, and linear effigy mounds, with hiking trails through the mounds and park, and an open-air picnic shelter. Current and potential projects include trail and interpretive

mound identification improvements, brush removal off of overgrown mounds, invasive species vegetation control and the Red Wolf Memorial Trail including a pond boardwalk.

WILD GOOSE STATE

TRAIL ~ This 34-mile limestone trail on an abandoned railroad grade has a southern Trailhead on Highway 60 and links the city of Juneau to the city of Fond du Lac. Potential and future projects include parking lot improvements and invasive species vegetation control.

GLACIAL RIVER TRAIL ~

This 3.5- mile trail is a paved hiking

and biking only path along HWY 26, running from HWY CJ near Clyman, south to 2nd Road near Watertown. It is part of the multi- county trail that runs south through Jefferson County and into Rock County. This trail connects to the Wild Goose State Trail via road routes to & thru Clyman, and then to the WGST southern trailhead at Highway 60.

GOLD STAR MEMORIAL TRAIL ~ To honor the fallen military, the newest East-West paved hiking & biking only trail system will eventually link Mayville, Horicon, and Beaver Dam to the Wild Goose State Trail. Phase 1 from Mayville's Theiler Park to Horicon Marsh, had its Grand Opening in June of 2019. A route to walk your bike through the marsh to Horicon has been established, and a signed city bike route through the city of Horicon is completed. Grant applications and funding campaigns continue to build this trail onwards to Beaver Dam. Phase 2 from Horicon to the Wild Goose Trail is the current priority.



RESTORATION EFFORTS AT NITSCHKE MOUNDS

Restoration efforts continue at Nitschke Mounds County Park. Over the past decades many invasive species have not only gotten a foothold in the park but have taken over many areas. The result is the dying off of many native species in some areas of the park, including many of the oak trees. The main focus up until now has been tackling several of the most invasive species, including Common and Glossy Buckthorn, Bush Honeysuckle and Garlic Mustard, that have greatly impacted the park. We received a boost this past Spring in our volunteer efforts when 32 students from Beaver Dam High school came and pulled 40 bags of Garlic Mustard in less than 2 hours! What an incredible effort that really benefitted the park!

This summer some volunteers began to tackle pulling Wild Parsnip. Wild Parsnip is native to Europe and Asia. It invades prairies, oak savannas and fens. It is often seen on roadsides, and in old fields and pastures. Anyone who comes in contact with Wild Parsnip needs to be extremely careful. If the sap comes in contact with your skin and



is exposed to sunlight, it can cause severe rashes, blisters, and skin discoloration. Volunteers need to wear gloves, long sleeves and long pants when handling this plant.

In addition to removing invasives, volunteers have also helped plant sapling oak trees, primarily bur and swamp white oaks in the park. Since there is currently little natural regeneration of oaks in the park due to invasives, it is a boost to these ecosystems to be able to plant oak saplings in several areas of the park.
